Your payroll for the last 3 fiscal years of 2,186,764.87 divided into your credit balance on July 31, 2006, resulted in a credit reserve ratio of .7. This ratio applied to Schedule A in Table 1 gives a 3.240% tax rate for 2007.

Pursuant to N.C.G.S.96-9(c) (3), this rate will become final unless a protest is made in writing and received by the Commission prior to May 1, 2007.

Taxable wage base per employee in 2007 is \$17,800.
