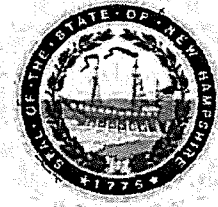

SAMPLE FORM

Section A:79 of the Unemployment Compensation Law requires the Commissioner to "classify employers in accordance with their actual experience in the payment of contributions ...and with respect to benefits charged against their accounts..." each July 1, to be effective for the one year period beginning on **July 1, 2012**

Explanations of tax rate calculations and tax schedules are listed on the reverse.

Your tax rate has been determined under Schedule I

In addition to reduced tax rates based on the merit rating provisions, employers whose rates are computed under Schedule I may have even lower rates, depending on the amount in the Unemployment Trust Fund. Reductions are provided for three different Fund levels. Emergency Surcharges under RSA282-A:84 and RSA282-A:84-a may also be applied if the solvency of the Trust Fund is in jeopardy. Listed below are the factors on which your merit or earned rate is based. Also listed are fund level reductions or surcharges that may apply. **Changes in fund level reductions and surcharges may change in a quarter and will be reflected in the tax rate shown on the Tax and Wage Report sent out each quarter by this department.**
